2. Commitment statement

3. Purpose

- 3.1. This policy sets out the framework for the translation of the IP arising from the Institute's research into products, services and processes to deliver economic impact. It encourages staff and associates to become creators and to identify IP with potential commercial value.

When individuals provide a service, IP is usually owned by the Institute and the service is governed by a service agreement / contract. These individuals are not eligible for Awards Inventors
