5. Responsibilities

- 5.1.2. Researchers must:
 - x Adhere to the data management plan submitted as part of the research bid (where applicable) and the contractual obligations governing research data (as defined in

5.3.3.In addition to requirements for researchers set ou Siection 5.1PIs should:

- x Include in research grant proposals appropriate consideration of the cost and time implication of data storage and management;
- x Develop and record appropriate procedures and questions for collection, storage, usage (including any nueses), access, and retention of the research data associated with their research programme
- x Ensure where research is conducted in collaboration with external research partners that suitable agreements or the ownership and use of research data are prepared following advice on the Institute's potential legal liability and agreed in writing by the parties concerned before the project starts (contact the Contracts Office to start the process);
- x Define therequirements for the selection of significant research data suitable for deposit at the conclusion of the research projection
- x Plan for the ongoing custodial responsibilities for the research data at the conclusion
